The points discussed and decision taken thereof are as enumerated below: -

- Dr. Kiran Kumar Ravulakollu, welcomed the members of the meeting and presented the PhD program policy and operating guidelines being followed at the university to the committee.
- Co-Supervisor regulations require a minimum of two publications and co-supervisor request application along with CV should be submitted for approval.
- The UGC regulations mandate a minimum four-year degree for undergraduate and PhD programs.
- The full-time undergraduate studies of four years is the eligibility criteria for undergraduate + Ph.D. programs.
- Clearance from COE regarding undergraduate programs of four and five-years duration is necessary.
- The review committee comprising external members is funded by the school for PhD research proposal presentations.
- Attendance of scholars is compulsory for PhD research proposal review sessions.
- PG and UG students should be invited at the time of PhD scholar's research proposal presentation review sessions.
- It is advised the school should be able to balance both Full and part-time students count financially as well.
- Full-time and Part-time PhD scholars must submit original TC certificates for admission by the registrar's office.
- The committee has proposed an Executive PhD program starting in July 2024, with a fee of 2 Lakhs per semester. The eligibility criteria include a minimum of 10 years of experience and participation in at least one consultancy project. It advises to develop the Standard operating procedures for executives for this program.

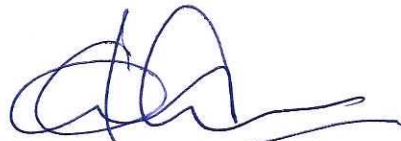

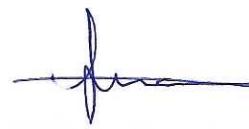

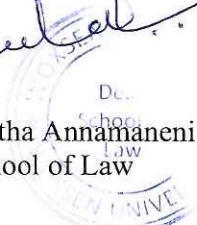
